- 7.1 Planning History/decision 2022/23 Update on recent applications received from Simon and reviewed at the meeting.
- 7.2 South Norfolk Planning application 2022/2335 Keepers Cabin, Mattishall Rd, Welborne. NR20 3LW extension and alterations to dwelling and erection of cart lodge. For information only following comments agreed previously The council is concerned by the ongoing piecemeal development around this site which may lead to a larger than appropriate development for the rural countryside in which it is situated. However the council cannot see any specific planning reason to reject this specific proposal and thus will take a neutral stance. Some concern was raised as to whether or not an additional access to the main road was required but the documents had disappeared off the planning site so that point wasn't checked.
