- 6.1 Planning History/decision 2022 Update on recent applications received from Simon and reviewed at the meeting.
- 6.2 South Norfolk Planning application 2022/2007 Garden room extension to include anthracite 4-part sliding patio doors. Low Farm Cottage, Church Rd, Runhall. NR9 4DW. Councillors support this application.
- 6.3 South Norfolk planning application 2022/2053 Conversion of redundant agricultural building to a dwelling, change of use of land to residential curtilage, installation of solar panels, extension to provide front entrance for disabled access. South of The Green, Runhall. The council had no specific issue with the conversion itself however, they are concerned over the access road The Green, Runhall. The state of this road is a cause for concern with damage to the road surface and verges having been reported to Highways on a number of occasions (and repaired sometimes). Further development at the end of the road may exacerbate the problems. The council would like to know Highways view on the state of the road and also whether the road could be improved as part of this development.
