

# Brandon Parva, Coston, Runhall and Welborne Parish Council

## **State of the Roads**

At the Council's recent meeting, several councillors said they had heard from several people who had needed to repair, replace and, even, insure their car tyres. The causes, especially in Coston and Runhall, were silt, stones and hedge cuttings on the roads. Please can all farmers, and anyone else responsible for debris on any road, please sweep the road immediately.

The Council will ask Norfolk County Council for a one-off road sweep of all the roads in our villages.

## **Village Name Signs**

A few months ago, the chair and vice chair took Bob West, our new Norfolk County Council Highways Engineer, on a guided tour of the roads in the parish. He agreed to programme a fairly long list of jobs that need doing. For example, he has already programmed work to repair or replace damaged village name signs and rusting posts. He also promised to renew white lines. Both of these will make a great difference to the overall look of our villages.

Other actions promised include work to deal with flooding on several roads, levelling of passing places, corrected spelling on a 'Welbourne' sign, reinstatement work after the current schemes by Anglian Water, renewed white lines, repair or replacement of damaged road signs.

You can be sure that the Council will try to make sure that all this work is done, as promised.

## **Noticeboards**

Installation of the new noticeboards for Brandon Parva, Coston and Runhall will take place very soon! At the same time, the old noticeboard in Horseshoe Road in Welborne will be removed unless residents want to keep it. Please let Bev know as soon as possible. A new noticeboard is already available outside Welborne Village Hall.

In future, if you have a notice that you would like displayed, please drop them off at Bev Long's. The new Welborne noticeboard, outside the village hall, allows you to add notices direct.

## **No Cold Calling**

We asked in our last newsletter for suggestions about possible Cold Calling Zones in our parish. Bev received no suggestion from residents so the Council will take no further action on this.

## **Broadband and Mobile Phone Reception**

Bev wrote, on behalf of the Parish Council, to Karen O'Kane, the Better Broadband for Norfolk project officer at the County Council. We wanted to find out what improvements are planned for the parish. This is the reply that we have had, included here in full to avoid any ambiguity:

Hello Bev,

I can provide an overview of the position for broadband, mobile is dependent on commercial investment rather than public subsidy, and therefore I can't provide details on planned mobile coverage.

### **Brandon Parva:**

17 properties served from Barnham Broom cabinet 2 which has already been fibre enabled with access to speeds over 20Mbps. White House Farm has access to speeds of 10-15Mbps

3 properties are served from Mattishall cabinet 4, a fibre solution is planned between October 2018 and March 2019

4 properties are served from Mattishall Exchange Only Lines, two fibre solutions are planned between October 2018 and March 2019 for three of these properties. There is no solution currently planned for Old Rectory

### **Coston:**

A solution is planned for the four properties served from Hingham cabinet 2, implementation planned first half of 2018

Two further solutions are planned for 11 of the 12 properties currently served from Barnham Broom cabinet 2. I expect implementation late 2019 /early 2020. There is no solution currently planned for Coston Hall

### **Runhall:**

A fibre solution is planned for 16 of the 18 properties currently served from Barnham Broom cabinet 2. I expect implementation late 2019 /early 2020. There is no solution currently planned for Low Farm and Low Farm Cottage

A fibre solution is planned for 21 of the 31 properties currently served from Mattishall Exchange Only Lines. I expect implementation between April and September 2018. There is no solution currently planned for 1, 2, 3, 4, 5 and 6 East Green, Mill House, The Mordice, Wood Farm and Wood Farm Bungalow.

### **Welborne:**

Four fibre solutions are planned for 70 of the 78 properties currently served from Mattishall Exchange Only Lines. I expect implementation between October 2018 and March 2019. There is no solution currently planned for 1, 2, 3, 4 and 5 All Saints Green, Greenacre, Foxleigh, and Old Hall Farm

The order for the rollout will be based on achieving the most efficient deployment possible, this is to ensure access to Superfast broadband for the maximum number of properties possible for the available funding.

One slight caveat, this is subject to survey and there always remains the small chance that this reveals something that would require more work than expected which could cause a delay or, in extreme cases, it is possible that severe technical issues will be discovered that prevent implementation altogether.

To explain why not all properties are covered, the rollout is based on the cost to provide a specific fibre solution, divided by the number of properties that will benefit to provide a per property cost. Funding is then allocated on this basis. The funding available for the BBfN programme is currently only sufficient to provide access for 95% of Norfolk premises.

The County Council considers broadband infrastructure a priority and as further funding becomes available coverage will increase towards an ultimate aim to achieve access for 100% of Norfolk properties.

Any property with access to a broadband speed of less than a minimum of 2 Mbps that will not benefit from a fibre upgrade can access the Government's voucher scheme. This scheme aims to cover the set-up costs for the implementation of alternative technologies such as wireless or satellite. ### **Phone box in Runhall**

Following a request from Jane Brown, the Parish Council applied to South Norfolk Council for a grant of £100 towards the upkeep and use of the redundant phone box in Runhall. The application was successful.

Jane and other Runhall residents have looked at the phone box at Honingham, which has been done up really well and has a share section. It also has some clever flip files showing local history. Mary and Terry Miller have generously said they will share all the archive material they have gathered on Runhall.

In the meantime, there has been some work on clearing the undergrowth and Clare Miller and her family have been busy with sandpaper.
